

Part I.

LaTeX

What is magic for? What use is wizardry if it cannot save a unicorn? —Peter S. Beagle, *The Last Unicorn*

Even the best technologies cannot save a unicorn—or make us better authors. They cannot tell us *what* to write. But they can help us to bring our imagination and ideas onto paper more quickly and efficiently. All you need to become a successful author is your mind, a pen, and paper. Everything you need to become a published author *more quickly* is in the following chapters.

While I try my best to explain each command and parameter, I keep those explanations focused on bringing you to the goal of publishing a book. There are other books meant to serve as a complete reference for all packages used in the template. Thus, it is best to look at Part 2 less as a reference and more as a walk-through to get your writing published using LaTeX.

1. Comparing Word and LaTeX

Everyone knows Word. However, "knowing" Word mostly refers to the ease of use, as it is a "what you see is what you get" (WYSIWYG) text editor. But if I asked how to use Word to refer to another document's text block and add that as a citation in a footnote, most people would have to look on the internet to find out how that could be done. While most of Word's functionality is available through icons, you still need to know where to look when something is not a standard command—like those used in formatting, making lists, or choosing fonts.

WORD · *Word* usually refers to *Microsoft Word*. Generally, it is used as an umbrella term for all word processors that directly show you what you will get as an end result (as opposed to first having to process the file). This approach is intuitive, but it makes editing large projects very complicated.

In LaTeX (pronounced /ˈlɑːtɛx/ LAH-tekh or /ˈleɪtɛx/ LAY-tekh), you create a text document that is then translated into an actual formatted document (your book). Formatting is done through commands you enter as text into the document. To write a LaTeX document, you never have to move your cursor, as you can enter everything by keystrokes alone.

LATEX · LaTeX is a document preparation system.

Word and LaTeX each have particular advantages.

If you know the commands, creating a LaTeX document will be quicker than writing a Word document. You never have to break your concentration to access a special command. Sure, there are shortcuts in Word, but those also have to be learned.

Because all commands are part of a LaTeX document, you can edit your text on any device with any editor you like, while Word documents require an installed editor (well, Word) that does not show the formatting and control information.

The upside of Word is its automated grammar check. LaTeX online platforms like Overleaf provide spell checks, but no integrated grammar check. We will have to wait for future releases in that regard.

Word offers integrated basic graphic functionality for symbols, while LaTeX has to rely on a rather complicated vector graphics engine.

Editing a Word document using different versions of the software might lead to compatibility problems and it will certainly not look the same in all versions. While there are collaborative online editors for Word, you are then on the same level as LaTeX online editors like Overleaf, and you lose the ability to work on your document while on the road without internet connectivity. Compatibility issues are especially problematic if you are co-authoring a book, working with an editor, or relying on exact page numbers. Do not forget that books can exist for quite a long time. Will your Word file still work in 10 or 20 years when it's time to release a new edition of your book or use parts of your book in a new book or article?

LaTeX' more substantial post-processing of each change allows for much more complex algorithms, which provide you with better hyphenation and professional-looking typography—both features come out of the box and require little to no adjusting. In LaTeX, the document is processed in the background with a delay (a few seconds up to several minutes), while Word has to provide any change in real time, which requires that editing is optimized primarily for speed. While LaTeX updates the entire document with each committed change, you need to update some elements manually in Word (for example, the table of contents and the index).

In LaTeX, an element of the style of the entire document can be changed with a single line of code, while it usually takes several clicks in Word to change the style of a document. For example, in LaTeX, changing the font style of all list entries can be done centrally in one place, while in Word, you have to manually go through all of your lists to make this change.

Changes in styles are hard to track in Word. While Word does have a sophisticated versioning system, this applies only to the text itself. The style information (for example, the formatting of headers or footers) in Word is not part of the visible document. Hence, changes to the style are not directly visible in the document version history.

VERSIONING SYSTEM · A *versioning system* is a tool to track changes to a document. That means you can go back and check what has been changed and by whom.

If your document contains graphics, processing Word files can become really slow, or the program might even crash. Why? Because while you are editing, all the images have to be cached somewhere, which uses a lot of memory. When editing LaTeX documents, images in the editor are visible only by their text reference and are only later—one by one—automatically compiled by LaTeX into a PDF or e-book.




Figure 1.2.: Example of a ligature.

LaTeX is known for its beautiful typography. For example, it supports kerning (see Figure 1.1) and ligatures (see Figure 1.2), giving a typeface its finishing touch. Improved hyphenation, proper small caps, and proper justification are other features LaTeX offers that Word cannot do as well or without additional work.



Figure 1.1.: Example of kerning applied to a typeface.

While Word has several built-in tools that support multiple languages (dictionary, basic grammar check, special characters, etc.), it is not designed to handle multiple languages simultaneously. If you want to produce, for example, a German version and an English version of your book, the best advice (using Word) would be to use two separate documents and translate and compare them para-

graph by paragraph. In LaTeX, a single document can contain multiple languages. To create a multi-language project, you can put each paragraph of the second (or third) language below the original language. This makes translation work more manageable and reduces work for synchronization when making revisions. This is possible by a simple switch command that uses all entries marked with either one language or with another. Check the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen) for more details.

In LaTeX, you can add functionality to switch between e-book and print output without having to manage two separate documents. For example, my *Philosophy for Heroes: Knowledge* project produces four output files: the German e-book, the English e-book, the German PDF, and the English PDF. Even if your ultimate goal is to focus on the printed version of your book, merely having a more affordable e-book version will help to increase sales as it gives your readers a choice. Those who do not have a preference for reading your book in print or as an e-book might opt for the less expensive version rather than not buying your book at all.

Because LaTeX documents are compiled, you have the option to build your document not as one huge file like in Word but as a collection of many files.

As mentioned above regarding images, you can also include text files at any part of the document (as opposed to copying the whole text into one huge file). This makes it easier to divide the work and proceed section by section versus having to locate the part you are currently working on each time you open the document. It also makes rearranging sections easier: you no longer have to copy and paste pages over pages (never being sure if you have successfully copied everything and nothing was lost). Instead, you just move the *reference* to a section to another place. For example, let us assume you write a book about dogs and cats and first discuss dogs, then cats. In LaTeX, you would put each discussion into a separate file and include them in your main file like this:

\input{main/aboutdogs}
\input{main/aboutcats}

Moving your discussion about cats to the front is done by simply switching the position in the main file:

\input{main/aboutcats}

\input{main/aboutdogs}

If your document contains formulas, LaTeX provides an entire scientific library of functions to edit and display them directly in the document. While you can create basic formulas in Word, you need to use a separate program to create and embed an image for any complex mathematics. Likewise, especially nonfiction books rely heavily on citations. To manage your sources in Word, you need a separate plugin or third-party program (like *Citavi*), while LaTeX supports the most widely used standard *BibTeX* for free, with no plugin required.

CITAVI · *Citavi* is a plugin for Word (see https://www.citavi.com) to manage your bibliography and citations.

LaTeX is open source and free (even the online editor Overleaf is free if you can do without password protection), while you have to pay license costs for Word.




Figure 1.3.: Comparison of Word and LaTeX depending on the complexity of the task: for natural sciences, anything more complex than articles takes more effort in Word; for social sciences, anything more complex than papers takes more effort in Word; for novels, book series take more effort in Word than in LaTeX.

Ultimately, it depends on your needs. If you want to write a complex document like a

book, the advantages of LaTeX outweigh those of Word. If you want to quickly write a few pages, Word is superior. For longer and more complex books, LaTeX takes less effort (see Figure 1.3). In this book, I will help you to get your book done and published with LaTeX using the free template provided with the book.

Summary: Word is great for quickly writing a few pages, while LaTeX is better for more complex documents such as books. LaTeX provides better typography, graphics, compatibility, and multi-platform support than Word, but it requires learning the commands and therefore using LaTeX might take longer to create a document.

2. Generate Your First E-book

So... how do we use LaTeX? What do we need to install, set up, etc.? And just how do we use LaTeX to create an e-book? For now, we will focus on getting you started generating a PDF and e-book. Later, in Chapter 3, we will go step by step through the process of copying your book from your text source (e.g., Word) to the template.

2.1. LaTeX Support

While we have tested the template that comes with this book several times, you will likely encounter an issue not discussed here. Creating a document in LaTeX *is* more complex than doing so in Word, but even in Word, there are issues you might run into where the solution is not immediately apparent.

If you encounter any error or have a question about LaTeX as it is used in the template, please do not hesitate to contact us. The question and the answer might be added to an FAQ for other readers. We offer free support if you provide us with a link to your Overleaf project. For major changes, one of our LaTeX developers can help you at an affordable rate. But most issues can probably be solved immediately and at no cost ("You forgot to close the parentheses," "You need to load package X," "Your graphics file is corrupt," etc.). Simply contact us at **mail@lode.de** and we will see what we can do!

For general LaTeX questions, you can also check out the community at https://tex.stackexchange.com. If you post a brief (but working) example with LaTeX code with which you are having a problem, the community can usually provide high-quality advice. If you encounter specific technical issues with the tex4ebook, you can also check whether there are open issues on the website of the tex4ebook maintainer: https://github.com/michal-h21/tex4ebook.

2.2. Signing up at Overleaf

Before we start, yes, setting up LaTeX the first time is more complicated than writing a letter in Word. But there are many solutions available that allow you to use LaTeX without much hassle. One of those solutions is Overleaf, which I am using for writing this very book (and all my other books). Overleaf is a collaborative online editor and project manager for LaTeX documents. It is available free for smaller projects that do not require password protection. If you want to keep your LaTeX code private, I recommend the Pro upgrade, which also adds full project history, access management, priority support, and support for larger projects.

If your goal is to try things out and work on your book with a professional editor, you do not have to spend money on Overleaf for private projects or larger projects. We can host the project on our Overleaf account and manage everything for you. Drop us a message at mail@lode.de!

OVERLEAF · Overleaf is an online editor and project manager for LaTeX documents. It manages your project with a versioning system and automatically compiles your LaTeX code into PDF and (with some help) HTML. It is free for public projects and does not require installation or setup. You can get an account here: https://www.overleaf.com.

Overleaf requires no installation. Just register an account, use my template, fill in your text, and you are ready to download the necessary files for creating a print book or e-book. If you are using a different LaTeX website or your own local installation, a different configuration might be required. To register an account on Overleaf, simply go to https://www.overleaf.com, enter your email and password, confirm the email, and log into your Overleaf account at https://www.overleaf.com clicking on Log In.

2.3. Copy the Template

If you do not want to use the template, check out the appendix of the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen).

Once you have your account, you have two options to get the template:

- go to https://tinyurl.com/latextemplate2023; or
- go to https://www.overleaf.com/latex/templates, searching for **Book Template for Amazon KDP**, **Leanpub**, **and Google Play (e-book and PDF) 2023**, clicking on the entry, and pressing **Open as Template**. Note that there is an earlier version available as well. Make sure you get the 2023 version!

Once copied, you can access the template via your Overleaf project view (go to https://www.overleaf.com and click on **Projects** or go directly to https://www.overleaf.com/project); your new project should be listed there.

The template itself needs to be adapted, of course—after all, it is *your* book, not mine. But for now, let us focus first on how to get from the template to a book.

So, navigate to your project view (https://www.overleaf.com, **Projects**) and click on the new project **Book Template for Amazon KDP, Leanpub, and Google Play (e-book and PDF) 2023**. In the opened window, you should see a menu bar at the top with the **Menu** button that opens the options for the project. On the right, you will see a preview of the PDF output. Remember what I mentioned at the beginning of the book: LaTeX is not a "what you see is what you get" editor. Instead, whatever you write has to be compiled into a PDF. Hence, you have the actual editing window in the middle (horizontally) and the separate output window on the right side of the screen.




Figure 2.1.: The project screen in Overleaf.

2.4. Create a PDF

The template is set up to produce both EPUB and PDF files. The EPUB files can later be converted into formats that can be read by a Kindle e-book reader, while the PDF files can be used for printing or reading on a computer screen. In addition, there is an option to turn your LaTeX project into a HTML file to be used for easy copy and paste. For now, let us first create a PDF.




Figure 2.2.: The project settings screen in Overleaf.

Click on the **Menu** button at the top left. A new panel shows up (see Figure 2.2). In the **Settings** section, click on the drop-down menu right of **Compiler**. We want the PDF output, so select **XeLaTeX** and select **2022** as the **TeX Live version**.

XELATEX · XeLaTeX is a LaTeX typesetting engine with an extended font, as well as UTF-8 encoding (for special characters) support. It takes longer to compile with XeLaTeX than with the more basic pdfLaTeX.




Figure 2.3.: Download the PDF via the PDF view.

To download the PDF of the *XeLaTeX* output, simply click on the third symbol (**Download PDF**, the second symbol to the right of **Recompile** in the PDF view, see Figure 2.3).




Figure 2.4.: Download the PDF via the Menu.

Alternatively, you can click on **Menu** on the top left and click on **PDF** (see Figure 2.4).

Done! Your first PDF. This PDF could be used to upload to on-demand book services like Amazon's KDP.

2.5. Create the EPUB Output




Figure 2.5.: Switch to EPUB generation by changing the compiler in the Menu to pdfLaTeX.

To create the EPUB file, we need to switch from *XeLaTeX* to *pdfLaTeX* output. For this, click on the **Menu** button at the top left, and this time, select *pdfLaTeX* in the **Settings** section, in the drop-down menu to the right of **Compiler** (see Figure 2.5).

PDFLATEX · *pdfLaTeX* is a basic LaTeX typesetting engine that translates LaTeX documents directly into PDFs or HTML files (with the help of *TeX4ht*).




Figure 2.6.: Click here to select the *latexmkrc* file.

Next, on the left side, scroll down to latexmkrc (see Figure 2.6).

There, remove the "#" in front of this line (first option):

```
# system("tex4ebook -j output -c htlatex/enumerate-fix main");
```

If you are switching back to XeLaTeX, remember to comment out this line again (add a "#").




Figure 2.7.: Click here to recompile the project.

Switching the output requires you also to recompile your project. For this, click on **Recompile** in the menu above the preview window on the right (see Figure 2.7).




Figure 2.8.: A red box with a number on the document icon indicates an error.

Before continuing, wait until the compilation is finished. If you encounter a problem here (and a little red box with a number appears on the document icon right beside **Recompile**, see Figure 2.8), please contact me at **mail@lode.de** and I will help you as soon as possible to fix the issue. A possible fix (especially after switching compilers) is clicking on "Logs and output files", then on the red **Clear cached files** button, and then again on **Recompile**.

If no number appears or if there are only warnings (orange box), you can proceed with the download.

2.6. Download and Convert EPUB to Kindle

We need another tool to publish the e-book on Amazon, namely the *Kindle Previewer*. Go to https://www.amazon.com/Kindle-Previewer/b?node=21381691011 and scroll down to the download links. If the link is unavailable or broken, simply search for **Amazon Kindle Previewer** using a search engine. Once downloaded, start the installation. It will associate EPUB files with Kindle Previewer, meaning you need only to download the EPUB files to convert them.

KINDLE PREVIEWER \cdot *Kindle Previewer* is a Windows and MAC tool to load HTML and EPUB files and convert them into KPF and MOBI files for upload to Amazon. The tool also allows you to preview the file as a customer would see it on a Kindle eReader.




Figure 2.9.: The EPUB file with the HTML output, style information, and images can be downloaded in the "Logs and output files" screen at the very bottom.

For downloading the e-book, you have to download the **EPUB** file by clicking on the **Logs and output files** icon at the top of the right window, scrolling all the way down to **Other logs & files**, and selecting the **output.epub** entry, see Figure 2.9).




Figure 2.10.: Importing the EPUB file in Kindle Previewer to convert it into a KPF or MOBI format.

A download with the EPUB file should start now, and, once completed, Kindle Pre-

viewer should start automatically (or you first need to click on the file, depending on your browser's configuration). If you want to convert an EPUB file already downloaded on your computer, start the Kindle Previewer manually, select **File / Open Book** (see Figure 2.10), browse to the directory where you have the EPUB file, and press **Open**. This starts the conversion process.

Note that if you also want the HTML output (for example, to copy contents), check out the appendix of the accompanying book, (*Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One*, https://amzn.to/3GCEGen).

2.7. Converting EPUB to KPF with the Kindle Previewer

For general information about the Kindle Previewer, check out its homepage at https://kdp.amazon.com/en_US/help/topic/G202131170

Depending on the book size, converting an EPUB file to a KPF file might take a moment. During conversion, you will see the "Converting your book to Kindle format" message on the screen. Once finished, a virtual Kindle reader should show up where you can browse through your book. If you are happy with how the contents look, press **File / Export** in the menu, and press **Export**. For the name of the exported file, I recommend including the current date to prevent confusion when uploading (for example, *ebbwltaw-01012023.kpf*). You can select different output formats. Choose the (pre-selected) format **Books(.kpf)**, which is the newest and most compatible format.

A message box should appear that reads "Book is successfully exported here." You can safely ignore the warning message "Enhanced typesetting is enabled for the book being previewed, but it is not supported in the exported file." This refers only to the fact that any fonts you are using in your LaTeX project are ignored and replaced by the respective fonts of the e-book reading device. Now you have a KPF file that you can use later to upload to Amazon's KDP platform and release it directly as an e-book on Amazon. I discuss the details in the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen), but in essence, that is the entire publishing process, at least from the technical side.

2.8. Versioning

Before you continue: while you are learning LaTeX, you should create a backup whenever your project compiles successfully. You can click on **History** (top menu, see Figure 2.11), then on **All history**, then on **View single version**, then on **Label this version**, then enter a name for the backup.



Figure 2.11.: Setting the name of the current version of the book for later reference.

It is best to name each backup by the milestone you have reached so that you later know at what point you have made the backup. For example, after polishing the files for an e-book release (but before polishing it for print), you could name it "e-book polishing complete."

You can always go back to a previous version and compare your changes. Click on **History**, then on **Compare to another version**, then on **Labels**, and then on a file in the list on the left side with a note "edited" right beside it. That being said, you do not have to save as you write. Your latest changes are always saved automatically.

Summary: This chapter showed you how to generate a PDF file and an EPUB file from the LaTeX template. You signed up at Overleaf, copied the template, switched the output from XeLaTeX to pdfLaTeX, downloaded the PDF and EPUB files, converted the EPUB to KPF with the Kindle Previewer, and created backups of your project.

3. Filling the Template

Now that you have experienced the steps of creating documents with the template, you can start to add content to them. In this section, we will go through each file of the template (https://tinyurl.com/latextemplate2023) and give you a "to do" list of items you can work on one by one—from the title to the appendix.

One way to understand the structure of a book is to imagine how books were created before the digital age. Imagine various groups of people working on the book and handing over the results to the next group. At the beginning of this process, there is the core material that makes up most of the book: the individual chapters and sections. Those are surrounded by the front and back matter, which consist of several layers. The author hands the text of the *chapters* over to the editor, together with a note introducing the author's work (the *preface*). The editor adds the *table of contents*, the *index*, *bibliography*, *quotation sources*, and maybe an *appendix* (containing summaries from throughout the book), and hands the book over to the *publisher*.

The publisher adds information to the book, too. That is, first the *publisher* page itself with the year of publication, ISBN number, copyright note, and publisher name, and then a description of how the book was created and, for example, how the reader can contact the publisher with any questions (the *foreword*). All the parts are then put into an envelope (consisting of the *series title* and *half title*) and handed over to the cover designer. The cover designer creates the cover (front, back, and spine), packages it together with the book into another envelope (consisting of the *title page* including the cover picture), and hands it to the printer.

3.1. Main Document /main.tex

The main document of an Overleaf project is the file in which Overleaf starts processing your project. When looking to make major changes like adding, rearranging, or removing sections and chapters, this is also the place for you to look first.

By default, the main document of an Overleaf project is main.tex. You can find this

file on the left side in the project file overview. You can change the project's main document in Overleaf by clicking on "Menu" under "Settings / Main document."

3.2. Global Setup

The first file included in *main.tex* is *setup.tex*. This file defines all the global parameters of your book—for example, the book's dimensions, the book's author, and the book's title. In the left project window, scroll down until you see *setup.tex*. Click on it and start editing the file:

3.2.1. Title Information

- Replace "The Title" with your book title;
- Replace "The Subtitle" with your book subtitle;
- Replace "Publishing Company" with your publishing company's name; and
- Replace "Location of the Publishing Company (city)" with your publishing company's location (the city), and "https://www.lode.de" with the URL (using https://) of your publishing company's website.

About the last two points, if you do not own a company, put in your own name and address and leave the URL empty. Note that from a legal standpoint, the exact requirements for providing the address depend on the country where you are publishing the book. Writing down all the information puts you on the safe side; if you want privacy, you must check what is required by law (and perhaps consider a P.O. box). Alternatively, just contact us (mail@lode.de), and maybe we can publish your book, and you will not have to worry about any paperwork.

We also need two cover versions, one for the e-book (JPG: low resolution, lossy compression) and one for print (PNG: high resolution, lossless compression). The reason is that (at least on platforms like Amazon) your profits for each e-book shrink depending on the file size. In 2023, this download charge for Amazon.com was around \$.15 per MB, so a 10 MB e-book would reduce your profit per book by nearly \$1.50 (check https://kdp.amazon.com/en_US/help/topic/G200634500 for current prices depending on the country of publication). For print, the file size can be ignored, and thus, the

image quality can and should be as high as possible.

Rename both versions of your cover (PNG and JPG) *cover.png* and *cover.jpg* and upload them into the *images* folder. If you want to use different filenames, simply upload your cover files and replace the file name entries in the *setup.tex* and *output.opf* file.

For the latter, see the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen).

If you do not have a cover file, skip this step. I discuss cover creation in the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen).

To upload the cover files, click on the *images* directory in the left project window, click on the arrow, select **Upload**, and then "select from your computer." If the files already exist, they will be overwritten. The most straightforward approach is to rename your cover file to fit the existing template; otherwise, you have to change the corresponding entry in the *setup.tex* file:

3.2.2. Publisher Information

To set up the publisher information page:

- Replace "Your email address" with your email address;
- Replace "First" with the edition number;
- Replace the three ISBN numbers with your e-book's, softcover's, and hardcover's ISBN numbers;
- Replace "Your editor's name" with your editor's name;
- Replace "Your designer's name" with your book cover designer's name;
- Replace "Your image sources" with your image and icon source (e.g., "Shutterstock"), including its license type; and

■ Replace "Your newsletter email" and "Your newsletter URL" with the email and URL (using https://) where people can subscribe to your newsletter.

You can skip replacing the ISBN numbers for now. What numbers to enter here depends on what publishing service you use. For example, for Amazon, see the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen) for more details.

3.2.3. About the Author

Next, fill in information about you (the author):

- Replace "Your name" with your name;
- Replace "Your city" with your location;
- Replace "Your country" with the country where you live;
- Replace "Preface date" with the date when you have written the preface (and finalized the book); and
- If you want, upload a high-resolution (*author.png*) and a low-resolution picture (*author.jpg*) of the author into the *images* folder. Also, uncomment the "% useAuthorImagetrue" line.

3.2.4. Series Title

If your book is part of a series, uncomment the "%

seriestrue" line by removing the "%" and filling out the titles of the parts and the name of the book series. If it is not the first book of the series, comment out the "

firstBookOfSeries" line by adding a "%" and filling out the number and title of the previous part of the series, and uploading the images of the previous part. In the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen), I discuss how to write a series. In the following paragraphs, we will assume that it is a standalone book.

3.3. File Structure

Now that we have filled in the global information, we can go file by file to replace the actual text blocks. In the accompanying book, (*Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One*, https://amzn.to/3GCEGen), I discuss adapting the *structure* of the book, meaning in which sequence the chapters are placed in the book.

3.3.1. Front Matter

In the left project window, click on the *front* folder. You will see a list of several files open.

- Select *front/title.tex*. This will be the first page of the document. Nothing needs to be done here, we filled all variable elements automatically using the *setup.tex*.
- Next, open *front/half-title.tex*. In the print edition, this comes after the title on page 3 of the book. Here, too, nothing further needs to be edited.
- Next, open *front/publisher.tex*. This page is usually reserved for information about the book as a product. It lists information about when the book was produced, by whom, and how someone can reach you. If you have filled out the *setup.tex* correctly, your work in this file is done.
- Next is the **dedication** page (see *front/dedication.tex*). Here, you can thank the people who helped you create the book. This page stresses that books build on other people's work. When writing it, think of it as a letter you would send to those people. Some people just write, "To my husband/wife/parents." If you see it as but a chore and want to express your gratitude to those people in person rather than in writing, you can safely leave out the dedication page. In the accompanying book, (*Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One*, https://amzn.to/3GCEGen), I discuss how to rearrange, add, or remove entire pages or sections.
- Another optional page is the **epigraph** page (see *front/epigraph.tex*). This page sets the theme for the book. This can be a quote, a picture, or anything you think could fit here. Here you can be creative and put some emotion into your book, even if it might be a dry book about LaTeX and project management. In my book *Philosophy for Heroes: Knowledge*, I have used the epigraph to introduce the reader to the summary boxes—insights into philosophy and linguistics—that I have put at the end of every

section. They tell a meta-story. They are the icing on the cake. For your epigraph, consider whether you want to add a particular plot or theme to your nonfiction book. The epigraph page is the perfect place to introduce this concept.

- Next comes the **foreword** (see *front/foreword.tex*). This is written by the publisher or you, with your self-publisher hat on. It should focus less on the book's content and instead focus on the book's production process. Encourage the reader to give you feedback and advise how he or she can contact you with an issue with the book, such as an error. Alternatively, the foreword can be written by an expert in the field as a type of endorsement.
- After the foreword, it is now up to you, the author, to introduce the book in the **preface** (see *front/preface.tex*). This can include how you arrived at the decision to write it, a personal note to the readers, and an "elevator pitch," a short introduction telling the reader why this book is an essential read. Try to be personal and try to stay away from sales talk or corporate speech. Add a quote by your favorite author as a finishing touch. You have already entered the information about you, the author, and the book series (if applicable) in the *setup.tex*, so you are done with this file, too.

This concludes the front matter of the book. The remaining file, *series-title.tex*, is discussed in the accompanying book, (*Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One*, https://amzn.to/3GCEGen).

3.4. Main Matter

In the folder list in the project view on the left, you will see a folder named *chapters*. This is the place for the main content, with a separate file for each chapter. Inside the *chapters* folder, you will find *0-latex.tex0-latex.tex*, *01-advantages-latex.tex*, *02-generate-first-ebook.tex*, and *03-filling-template.tex*. Those are just sample files showing excerpts of this book (the first three chapters of Part 2, including this chapter). You can delete the files after adding your own material.

- If you already have your whole book (or portions of it) ready in one big Word (or text) file, you first need to separate the text by chapter.
- If you have already separated your book into individual chapters, each in its own file, proceed as outlined below.

For each chapter, create a new file in the *chapters* directory in Overleaf. Instead of calling them *first-chapter.tex*, *second-chapter.tex*, etc., name them according to their actual chapter titles, preceded by the chapter number (for example, in this book project, I have named the file of this chapter *03-filling-template.tex*). This way, you can more easily refer to them later. Naming the first part of a chapter file according to its chapter number (01, 02, etc.) helps with navigation, but you can use any naming convention you like (just make sure you are consistent).

Once you have identified all chapters and created the files, you need to copy the text into each chapter file. For this, simply select the text of your chapter (including the title), and copy and paste it into the corresponding .tex file. There is a chance that the project will no longer (or only partially) compile after inserting your text. This can happen if your text already contains what Overleaf interprets as LaTeX commands. The most frequent issues are:

- **Percentage signs** % *They are interpreted as comments by LaTeX and are thus ignored.* Replace them with "\%"
- **Curly braces** { } *They are interpreted as special commands by LaTeX.* Replace them with "\{" or "\}"
- Dollar signs \$ They are interpreted as starting or ending a mathematical formula.

Replace them with "\\${}"

■ Underscores _ They are used in mathematical formulas. Replace them with "_" or remove them altogether, especially in file, chapter, section, and figure names. It is fine to keep them as part of URLs (inside a \url command) or code (inside a \lstlisting environment).

Please note that there is no simple way of copying the formatting (bold, italic, font size, lists, indentation, etc.) from Word to LaTeX. In the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen), I discuss how to format the text manually, especially if you already have your text formatted in Word. For any future books, I recommend that you write them in Overleaf from scratch and use the LaTeX formatting as you write.

3.5. Chapter Header

One way of starting each chapter file is by defining the chapter title and label, and adding a quotation to set the tone of the chapter. You can reuse the code for each new chapter file by copying and pasting the following code to the top of your files:

- Replace "Replace with the Chapter Name" with your chapter title.
- Replace "chaptername" with your chapter title label (no spaces, only lowercase letters).
- Replace the quotation text, add the person's name, and (if you have it) the bibliography item. If you do not have the source, remove the following line:
- , $\citetitle{bibitem} \inf {@\subset itetitle{bibitem}} \citetitle{famous person-bibitem-quote} \citep[p.~123]{bibitem} \fi$

There are several approaches to organizing your book's individual chapters and sections. Personally, I prefer to divide my content into small (ideally independent) slices, with each slice providing the reader with some benefit. The accompanying book, (*Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One*, https://amzn.to/3GCEGen) discusses the entire process from idea to publishing.

3.6. Back Matter

The back matter of a book typically consists of two elements: references and connecting with the author.

- By "references" I mean the glossary, questions to reflect on about the book's contents, a summary of the main points of the book, the index, a list of image and quotation sources, and the bibliography. Whether or not you want to include the glossary, the questions, and the summary of ideas depends on the book you are writing. The index is created automatically, but it will need some work within the text of the main matter of the book, which I discuss in the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen). The same applies to the bibliography.
- By "connecting with the author" I mean the "About the Author" section, information about your (or your publisher's) other books, an optional section about how the book was created, and a polite reminder to your readers to leave a written review online. If you want to give the book a finishing touch, end with a short quote on the last page.

For the second part, let us go through the files of the template one by one.

- If you have other books published, the *back/advertisement.tex* is the place you can list them. In the template, replace or remove the pictures of the book covers, and replace or remove the descriptions of the individual book entries.
- Next, you are free to use the text in *back/amazon.tex* if you like or adapt it to your own needs, depending on where you publish the book. This is a reminder for the reader

to provide you (and potential future readers) feedback.

- For information about you, the author, open the *back/author.tex* file and replace the quotation text and add a short text describing your motivation, your professional background, what you are currently doing, and how to contact you.
- Beyond the cited works and your other books, you can also direct the reader to additional book recommendations to delve deeper into the subject. For this, use the command \nocite in the back/recommended.tex file and list the recommended books by their book id from your bibliography file.
- If you want to tell a story about how you created your book (if you have not already done so in the preface), you can do so in the *back/thebooksstory.tex*. Use this chapter to summarize what you have learned while writing the book. This can help you to write better books in the future and might be interesting for the reader as well. Myself, I like to talk about what is going on in the background of what I do. It is up to you. The existing default text in the template describes to a reader how the book was created using the template and this book as a guide. Feel free to skip this one. In the accompanying book, (Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen) I cover how to reorganize or remove individual sections.
- Finally, replace the quote in *back/last.tex* with a quote of your choice in order to leave the reader with something to think about.

The remaining files in the back matter are as follows (see the accompanying book, Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One, https://amzn.to/3GCEGen for more details):

- *bibliography.tex*: The bibliography.
- *index.tex*: The index.
- glossary.tex: The glossary is added at the end of your book as a reference. You can add glossary boxes throughout your book to explain concepts. Create a separate glossary file in the *chapters/glossary* directory and use *input* to include them in your chapters and the glossary. Ideally, sort your glossary items in the *glossary.tex* file by their name.
- **questions.tex** and *ideas.tex*: Similar to the glossary entries, you can add questions and answers throughout your chapters and include them in the back matter as a refer-

ence. For better navigation, sort them by chapter.

q *quotations.tex*: If you are citing from other sources, list them in this file. This is especially helpful for e-book readers who might not have access to footnotes.

What about the table of contents? While it is generated automatically in both LaTeX and Word, updating it in LaTeX requires no additional work. As the project files are fully compiled after each change, you do not even need to manually refresh the table of contents. We still have to organize and format the text you have pasted into the book's main matter. Once that is done, your entire table of contents will show up in the output.

That is it! Your book is finished and we can now move on to polishing.

Chances are that a few issues have come up through the copying and writing process. *That is normal!* Remember, LaTeX takes a little bit of time to learn. But once you know it, it flows like a natural language. All it takes is patience. If you hit a wall, you can create a new copy of the template and progress in smaller steps. Even better, use the backup and restore feature (see the accompanying book, *Even Better Books with LaTeX the Agile Way in 2023: Streamline Your Writing Process and Connect with Readers from Day One*, https://amzn.to/3GCEGen for more details) using the top menu entry (**History**). Also, you can always contact us (mail@lode.de); we may have a quick fix for your problem. Alternatively, we could bring your book to the market together.

Summary: In this chapter, we went through each of the files in the template. First, we covered how to fill them. We started with the main document, *main.tex*, and created a global setup using the *setup.tex* file. We then filled in the front matter, main matter, and back matter. We learned how to organize chapters, create a book series, insert quotations, introduce the author, and leave the reader with something to think about. Finally, we discovered how to rearrange, add, or remove individual sections.




Figure 1.: Comparing complexity of *Word* and *LaTeX* depending on the application.





Figure 2.: Example of a drawing made in TikZ.

CITAVI · *Citavi* is a plugin for Word (see https://www.citavi.com) to manage your bibliography and citations.

L

LATEX · LaTeX is a document preparation system.

O

OVERLEAF · Overleaf is an online editor and project manager for LaTeX documents. It manages your project with a versioning system and automatically compiles your LaTeX code into PDF and (with some help) HTML. It is free for public projects and does not require installation or setup. You can get an account here: https://www.overleaf.com.

P

PDFLATEX · *pdfLaTeX* is a basic LaTeX typesetting engine that translates LaTeX documents directly into PDFs or HTML files (with the help of *TeX4ht*).

V

VERSIONING SYSTEM · A *versioning system* is a tool to track changes to a document. That means you can go back and check what has been changed and by whom.



WORD · *Word* usually refers to *Microsoft Word*. Generally, it is used as an umbrella term for all word processors that directly show you what you will get as an end result (as opposed to first having to process the file). This approach is intuitive, but it makes editing large projects very complicated.



XELATEX · *XeLaTeX* is a LaTeX typesetting engine with an extended font, as well as UTF-8 encoding (for special characters) support. It takes longer to compile with *XeLaTeX* than with the more basic *pdfLaTeX*.
