Note: This is by no means a full and complete introduction to \LaTeX . Its purpose is to introduce some of the symbols and notation used in various courses, and demonstrate how you can accomplish common tasks in \LaTeX . We encourage you to use this document as a template for your solutions.

Exercise 1

(a) My solution to this exercise is a bunch of **logical symbols**:

<code>\lor</code>	\vee	<code>\land</code>	\wedge
<code>\rightarrow</code>	\Rightarrow	<code>\Leftrightarrow</code>	\Leftrightarrow
<code>\neg</code>	\neg	<code>\neq</code>	\neq
<code>\equiv</code>	\equiv	<code>\not\equiv</code>	$\not\equiv$

Although we usually use them inline: $\frac{x}{2} - y > 4 \Rightarrow x > 2(y + 4)$, or in a block:

$$\frac{x}{2} - y > 4 \Rightarrow x > 2(y + 4).$$

(b) Can't forget the *set operations* and so forth: $P \cup \emptyset \not\subseteq Q$.

<code>\cap</code>	\cap	<code>\cup</code>	\cup
<code>\setminus</code>	\setminus	<code>A^{\text{c}}</code>	A^c
<code>\mathcal{P}</code>	\mathcal{P}	<code>\mathcal{U}</code>	\mathcal{U}
<code>\in</code>	\in	<code>\notin</code>	\notin
<code>\subseteq</code>	\subseteq	<code>\not\subseteq</code>	$\not\subseteq$
<code>\subset</code>	\subset	<code>\not\subset</code>	$\not\subset$
<code>\emptyset</code>	\emptyset	<code>\varnothing</code>	\emptyset

You may also want to define sets explicitly: $4 \notin \{1, 2, 7\}$.

(c) Some basic mathematical notation: normally, one needs to write `\mathbb{R}` to get \mathbb{R} , but we have defined shortcuts for you: `\R` works!

$$\mathbb{R} \quad \mathbb{N} \quad \mathbb{Z} \quad \mathbb{Q} \quad < \quad > \quad \leq \quad \geq \quad \neq \quad x^2 \quad \sqrt{y}$$

$$3 \cdot 3 = 3^2 = 9$$

(d) Here's a math table-like environment for setting up a series of derivations.

$$\begin{array}{l} T \\ \equiv \{ \text{rule to be proven} \Rightarrow \} \\ ? \\ \equiv \{ \text{rule to be proven} \wedge \} \\ F \end{array}$$

But if you don't want to use (a lot of) math inside a table, a normal table also works:

left	center	right	
l	c	r	
$x + y$	\equiv	$y + x$	

$a \vee b$
$\frac{\neg a}{\therefore b}$

Exercise 2

- (a) Regular expressions can be written as: $(a + \epsilon)^*(a + b)ab$.
- (b) Useful for writing about Turing machines, but also for concluding a proof: \square .
In fact, we can write a proof as follows.

Proof. It can easily be seen that this statement is concluded with a `\qed` symbol. \square

Exercise 3

We can specify an algorithm in pseudo-code as follows.

MYINCREDIBLEALGORITHM(A, v)
Input: an array A of n numbers and a number v
Output: an index i such that  $A[i] = 42$ , or NOTFOUND if no such index exists
1 i ← 1
2 while  $i \leq n$  and  $A[i] \neq 42$  do
3   A[i].update()
4   i ←  $i + v^2$ 
   /* the following loop runs over all of A                                     */
5 for  $j \leftarrow 1$  to n do                                           // use a different indicator variable here
6   something useful                                                    // you can write text if that's more succinct
7   if j is even then
8     A[j].flip()
9 if  $i > n$  then return NOTFOUND else return i

```

For analysis, you may want to know $O, \Theta, \Omega(n \log n)$ (not to be confused with o, ω).

Exercise 4

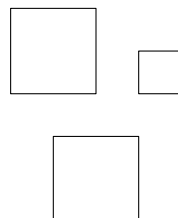
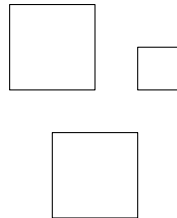


Figure 1: Three axis-aligned squares.

A figure (such as Figure 1) can be inserted, PDF format is preferred.

To insert a figure precisely where you want it to appear, you can leave away the figure environment. You will then however not be able to add a caption or refer to it.

The caption of Figure 1 can be left away completely, but you will not be able to refer to the figure anymore if you do that; the `\label` only works right after a `\caption`. Note how \LaTeX can automatically fill in the figure number for you, making it easy to refer to figures. The same approach works for tables, although it is common practice to put the caption before the table instead of below it; this can be seen in Table 1.
