


Fig. 1. Placeholder image of a Network with a long example caption to show justification setting.

This table reports coefficients and standards errors from ordinary least squares regressions. In all models we can reject the null that *Woman - Female* and *Woman - Male* are equivalent with $p < .01$. In models 2 and 3 we can reject the null that the gender gaps within sex are equivalent ($(\textit{Woman - Male}) - (\textit{Woman - Female}) = \textit{Man - Male}$) with $p < .001$.
